

# HICKMAN COUNTY, TENNESSEE

## RESOLUTION NO. 10 – 18

### WAIVE BUILDING PERMIT FEES FOR RESIDENTIAL STRUCTURES WHICH SUFFERED DAMAGE OR DESTRUCTION DURING THE SEVERE WEATHER OF MAY 1 - 2, 2010 AS IDENTIFIED BY THE FEDERAL EMERGENCY MANAGEMENT AGENCY

**WHEREAS**, Resolution No. 05-32 consisted of a document titled “Final Draft No. 2-2005, Zoning Resolution for Hickman County, Tennessee”;

**WHEREAS**, in the document referenced above, Article VII, Section 7.030, Subsection C, Fees, authorizes the Hickman County Commission to establish a schedule of fees for Building Permits and allows the Commission to alter or amend these fees;

**WHEREAS**, the Hickman County Regional Planning Commission, at their meeting of May 13, 2010, voted unanimously to recommend to the Hickman County legislative body that building permit fees be waived for those residential structures, identified by the Federal Emergency Management Agency (FEMA), as having been damaged or destroyed during the severe weather of May 1 - 2, 2010.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of County Commissioners of Hickman County, Tennessee, assembled in regular session this 24th day of May, 2010, that:

**SECTION 1:** Building permit fees shall be waived for those residential structures, identified by the Federal Emergency Management Agency (FEMA), as having been damaged or destroyed by the severe weather of May 1 – 2, 2010.

**SECTION 2:** The provisions of this resolution shall become effective upon its passage, the public welfare requiring it:

**SECTION 3:** This resolution shall remain in effect for a period of 36 months from the date of its passage and does not amend or otherwise change the existing Hickman County Zoning Resolution.
